## Regulations for Handling Dual Registration at I-Shou University

Adopted on October 9, 2009 at the first meeting of the University Academic Council in the first semester of the academic year 2009

- Article 1 The Regulations for Handling Dual Registration at I-Shou University (hereinafter referred to as "the Regulations") are made pursuant to Article 28 of the University Act and Article 3 of the Academic Rules of I-Shou University.
- Article 2 The term "dual registration" mentioned herein refers to the situation where a student is formally registered at I-Shou University (hereinafter referred to as "the University") at the same time as being registered with any other departments (institutes/programs) of the University or with any local or overseas academic institutions.
- Article 3 When taking courses at another academic institution, students with dual registration status shall make sure that such courses do not meet simultaneously with courses offered by the University. The credits and semester grades that students with dual

registration status have earned at another academic institution shall not be computed with the semester grades and credits earned at the University. If students with dual registration status are required to submit a master's thesis or a doctoral dissertation, they shall not propose a thesis/dissertation with identical titles and contents to both the University and the other academic institution; otherwise, the degree conferred by the University will be revoked, and they will be asked to return the degree diploma issued to them.

- Article 4 Students shall apply for dual registration in accordance with the Regulations before the beginning of the semester in which dual registration is desired. Those who study at another academic institution without prior consent from the University shall be expelled from the University.
  - Students who are at the same time registered with the University shall pay the tuition and other required fees based on their student status.
- Article 5 If students pursue a dual-degree at an overseas university that has entered into an agreement on dual-degree programs with the University, the Regulations for Dual-Degree Programs by I-Shou University and Overseas Universities shall apply, and such students will be exempted from Article 3 of the Regulations.
- Article 6 Matters not mentioned herein, if any, shall be subject to the Academic Rules of I-Shou University.
- Article 7 The Regulations become effective on the third day of promulgation after being adopted by the University Academic Council, the University Administration Council, and the University Council, and ratified by the President. The Regulations shall also be submitted to the Ministry of Education for future reference. The same procedure applies to any amendments to the Regulations.

Note: In the event of any disputes or misunderstanding as to the interpretation of the language or terms of the Regulations, the Chinese language version shall prevail.
