- Article 1 The Regulations for the Establishment of Curriculum Committees at I-Shou University (hereinafter referred to as "the Regulations") are made pursuant to Article 24 of the Enforcement Rules of the University Act and Article 22 of the Charter of I-Shou University.
- Article 2 I-Shou University (hereinafter referred to as "the University") establishes the Curriculum Committees at three different levels:
 - 1. the university-level Curriculum Committee (hereinafter referred to as "the Committee");
 - 2. college/center-level Curriculum Committees; and
 - 3. department/institute/program-level Curriculum Committees and the Preliminary Examination Panel of the Center for General Education.

The guidelines on the establishment of the Curriculum Committees and the Preliminary Examination Panel as referred to in Subparagraphs 2 and 3 of the preceding paragraph shall be drawn up separately.

The Curriculum Section of the Office of Academic Affairs is responsible for all matters relating to the Committee.

Article 3 The Committee is responsible for:

- deliberating the core competencies and performance indicators that students of different colleges are expected to have and achieve, as well as the curriculum planning and design based on the educational objectives, competencies, and performance indicators of each college;
- deliberating the educational objectives of the Center for General Education, as well
 as the curriculum planning and design based on its educational objectives,
 competencies, and performance indicators;
- deliberating curriculum planning reports, specialization-specific courses, changes of required professional courses, distance learning courses, service-learning courses, and inter-college/departmental credit programs submitted by college/center-level Curriculum Committees; and
- 4. deliberating the implementation and effectiveness of all courses.
- Article 4 The Dean of Academic Affairs, college deans, and the Center Director of General Education are the ex-officio members of the Committee. The Dean of Academic Affairs

also serves as the convener and chairperson of the Committee.

Each college and the Center for General Education shall select one or two faculty members, respectively, to serve as members of the Committee. Selected members shall serve a one-year term and may be re-selected.

The Committee shall also have one student representative who is nominated by the Office of Student Affairs to attend committee meetings.

Scholars and experts from within or outside the University may be invited to attend committee meetings for an exchange of views as participants without the power to vote, if necessary.

- Article 5 The Committee shall meet at least once every semester, and an ad hoc meeting may be convened when necessary.
- Article 6 A quorum of at least two-thirds of the total membership will be required to validate a committee meeting, and consent from at least half of the members attending is required for resolutions.
- Article 7 The Regulations become effective on the third day of promulgation after being adopted by the University Council and ratified by the President.

Note: In case of any disputes or misunderstanding regarding the interpretation of the language or terms of the Regulations, the Chinese language version shall prevail.
